There are a couple of things I would like to share which were published in a press release from the Michigan Dept. of Natural Resources. They are reminding us that after the heavy ice and snow cover melts, it may be common to discover dead fish or other aquatic animals. The fish actually suffocate. This is more common in shallow lakes. These kills are localized and typically don't affect the overall health of the fish or the quality of the lake. Hopefully we won't see too many.

I am also very happy to announce we have two new Leadership Team members: Danya VanderLugt and Bonnie Durbin Griffith. Their contact information is listed in this newsletter. We have a full team now and are just waiting for some folks to get back from their winter travels. Hess Lake Statutory Board (HLB) Update

Editor's Note: In addition to HLIA (which is a neighborhood association), Hess Lake residents are also served by the Hess Lake Statutory Board (HLB). HLB is a legal entity created by local government and focuses on issues of pollution, flood damage, and water conditions that affect public health and safety. HLB also works to increase the value of property by improving the quality of the lake and conservation of fish and wildlife. This statutory lake board can and has created an assessment district to assess the tax roll to fund various projects.

The Hess Lake Board had their most recent meeting on April 7, 2014. The lake was still very frozen and we learned from Savin Lake Services that we will be about four weeks later this year in doing any weed control. When the lake is going to be treated, Savin will post the times of any restrictions as they have done in the past.

The aeration system is in place and is ready to be turned on at the end of April. It is located in the cove between Zone 4 and Zone 5. We should not notice anything unusual in this area except some bubbles coming to the surface. Savin has agreed to attend Hess Lake's annual meeting which will be held on June 14, 2014 at 10:00am at the Brooks Township Hall. If you have questions about the aeration system that would be a perfect time to speak with the experts.
