Your HLIA remains hard at work throughout the year planning activities and monitoring issues that affect our lake community. HESS LAKE BOARD UPDATE

The statutory Hess Lake Board (HLB) met in September and approved the computation of costs for weed control for 2010. The HLB may assess an amount for the next year that is equal to what was spent in the present year plus 10%. The 2010 amount will be \$43,032.00. Front lots will be assessed \$93.08, back lots \$46.56, third tier \$23.28 and commercial \$187.04. HLB has cash on hand as of September of \$38,390.40. So we will have about \$81,000.00 available after whatever expense we have for the balance of 2009. We may or may not need a whole lake treatment in 2010. If so, it will be very costly. We are prepared and have plans either way. The complete document as to 2009 expenses is available at the Newaygo County Drain Commissioner's office.

Just a reminder for Hess Lake area property owners. HLB is an entity enabled by state law; Act 451 of 1994, Part 309, Inland Lake Improvements. The members are five in number. One appointed by Brooks Township (Dick Besser), one by Grant Township (Gary Noble), the County Drain Commissioner (Pat Baker), the County Commissioner serving the Hess Lake district (Adam Wright), and one at large member appointed by the aforementioned HLB members (Dale Dozeman) who must be a lakefront property owner. The Hess Lake Improvement Association, HLIA, may submit up to 3 names to the HLB, from which the board shall make its selection.

Our September meeting was also a joint meeting with Brooks Lake Board (BLB). BLB recently completed a lake study by Spicer Engineering. Their cost was around \$26,000.00. HLB helped in this study by paying to have water testing done where five inlets come into Hess Lake. We contributed \$1216.50 for these tests. The tests confirmed previous water studies at those locations with respect to nutrient loading, pH, temperature profiles, E.Coli, and oxygen levels. No changes from previous testing were observed. Our water is nutrient rich in phosphorus (P), a bit acidic (normal for conditions around Hess), oxygen levels are reasonable and E. Coli doesn't appear to be a problem.

After reviewing the results of the study on Brooks Lake, HLB believes paying Spicer to do the same for us would not offer anything new, or anything we did not already know, save one thing. That would be comparing present depth of the lake to previous depth records. We may consider doing the depth study only. Because we're not sure about the accuracy of older depth studies, the value in this would be a benchmark for future generations. In addition, in the spirit of partnership with BLB, we loaned them some money to help pay for their Spicer study. They will repay this no interest loan in January when assessment monies begin to come in.

Algae continues to make the water murky during the cottage season. The reason for this is our waters are warm, the lake is shallow, there is a lot of silty bottom sediment in the SE, S, and SW portions of the lake which extends outward. Phosphorus (P) bonds to solids (silt). Wind, rain events and boat traffic disturbs the silt and releases the P into the water table making it rich in food for algae. In 2009 we had an unusual continuously windy spring and summer, a lot of rain early and then the usual boat traffic. The fact that Hess is rather shallow, intensifies the problem. Thus, the murky water.

Speaking of rain events, we had several large ones, especially early in the year. The Wheeler Drain weir south of Hess Lake Dr. and the other weir north of the bridge over Wheeler were both compromised. Our county Drain Commissioner, Pat Baker, within a couple of days, under adverse conditions, repaired both dams. In addition, later in the spring, because a good deal of sand infiltrated Wheeler north of the bridge, Pat had the sand removed from the stream bed. The upstream holding ponds captured thousands of yards of sand that would have come into the lake or further compromised the stream from the bridge to the lake. That sand has been excavated twice this season, the latest in November. Work was also done on the banks of the upstream portion of Wheeler. Thanks, Madam Drain Commissioner, for your good work.

Algae again: Any effective treatment for algae is extremely short lived; maybe a day or so. It's not inexpensive. Dense blooms of algae tend to form and break up rapidly, depending on various weather conditions. (I gave a more detailed account of algae in an earlier newsletter) By the time our applicator arrived the bloom could have dissipated thus wasting money.

When our applicator does contact herbicide for E. milfoil and curly leaf pondweed, he has included some copper sulfate to kill algae for good measure. The herbicide is absorbed better by plants in clearer water, thus better resulting kills of noxious weeds.

A word about contact herbicides: The products used by our licensed applicator are approved and re-approved by the EPA and the State of Michigan. When applied properly (and they are) the products are harmless to man and beast. Some of these products are used on farm fields in the production of our food.

Our whole lake treatment is usually at 3-5 year intervals, if needed, for E. milfoil and curly leaf pondweeds, and uses floridone (Sonar). Floridone inhibits the plant's ability to form carotene, which plants need to maintain essential levels of chlorophyll. Simply, it causes E. milfoil and curly leaf pondweeds to starve to death. We apply it soon after the ice goes away if possible. Ergo: no milfoil or pondweed growth is possible. Sonar has no adverse effect on humans or animals or fish. There is no defined upper limit for human consumption of floridone that is harmful. Sonar is EPA approved at up to 150 parts per billion (ppb) for drinking water. Our applicator uses only 6 to 9 ppb for full effect on E. milfoil and curly leaf. Vegetation that we want to keep healthy in our lake is not significantly effected by this dilution. Maintaining healthy native vegetation in the lake is good for a variety of reasons, including providing fish habitat, absorbing nutrients (P) from sediment and helping to trap sediment from re-suspension in the water column.

Dredging: A Canadian researcher has recently found, surprisingly, that dredging portions of lakes can actually make algae problems worse under certain conditions. There are a lot of variables that we don't know about regarding this research such as correlations with depth of the lake, size of the lake, water temps, nutrient levels, etc. One of our HLB members is going to follow up on this. An HLIA board member is also looking into any recent positive developments in dredging. He has promised to keep your HLB up to date on what he has found. HLB looked into this a number of times over the last 25-30 years and found dredging to be extremely cost prohibitive, highly regulated, and we learned about some negative effects dredging has on the lake and its residents. We continue to be interested in whether dredging can be a viable alternative for Hess Lake.

Anyone interested in participating in the voluntary shoreline restoration project by planting deep rooted native plants near your shoreline next fall (2nd round), get with Gary Noble. As was done in the 1st round (fall 2009 & spring 2010), we anticipate plants being provided free to participants through Muskegon River Watershed Assembly discretionary funds from the Fremont Area Community Foundation. ICE FISHING..... Did you know?


- All shanties must have a name and address on all sides in 2" letters.
