VOLUNTARY SHORELINE RESTORATION PROGRAM Report from the Hess Lake Board

A proposed "Voluntary Shoreline Restoration Program" is moving forward based on significant positive feedback from a recent postcard survey sent to Hess and Brooks Lake residents this past winter. Program details are currently being planned with program introduction targeted for Summer/Fall 2009.

A goal of the "Voluntary Shoreline Restoration Program" is to provide lakefront residents an opportunity to become better stewards of their lake by planting native plants to:

- I) enhance the appearance of their shoreline property,
- 2) improve the water quality of their lake,
- 3) reduce surface water runoff into their lake, and
- 4) create habitat for butterflies and other desirable wildlife.

Another goal of the program is to increase awareness among lake residents about the negative impacts that traditional lawn/turf grass have on water quality. Turf grass lawns have short root systems, require regular mowing and watering, and many folks apply fertilizers/pesticides to keep turf grass healthy. However, much of what is applied to traditional turf grass lawns (nutrients like phosphorus in fertilizers and pesticides) and heavy rain, cannot be absorbed and runs off into our lakes, stimulating excessive weed growth and more frequent algae blooms, among other problems. In contrast, native plants and grasses have much longer root systems (that encourage greater infiltration of water), don't require mowing or watering once established and they don't need any supplemental applications of fertilizer or pesticides. Because of their longer root systems, native plants and grasses absorb more water, nutrients and help filter/cleanse water in the soil, thereby improving the quality of sub-surface (groundwater) that reaches our lakes. Native plants and grasses also provide habitat for many desirable types of butterflies and birds and can be designed accordingly, in addition to providing colorful aesthetics to any landscape. The objective here is for lakefront owners to convert a portion of their waterfront turf grass to native plants/ grasses for a more natural landscape that will help buffer the lake from surface water runoff impacts.

The "Voluntary Shoreline Restoration Program", as designed, will provide participants with information on different types of native plants and basic instruction on how/ where/when to plant. Participants can choose which native plants/grasses they want to add to their lakefront landscape. The program will also subsidize the cost of available native plants/grasses to participants that commit their time and labor to planting them during Summer/Fall 2009. Monies to subsidize the cost of native plants will come from Muskegon River Watershed Assembly discretionary program funds provided by the Fremont Area Community Foundation.

This voluntary program is a great way for each lakefront and near shore owner to do something positive to help protect the lake we enjoy while enhancing the appearance of their property. Further program announcements and education/instruction meetings will be forthcoming through both the Hess Lake Board and Brooks Lake Board. The Hess Lake Improvement Association encourages all lake residents to participate in the "Voluntary Shoreline Restoration Program".
