

???? DID YOU KNOW THAT HESS LAKE IS EUTROPHIC ????



You are probably thinking, "What is eutrophic?" To answer that question, let's look at the history of Hess Lake.

Lakes that are scattered across the Newaygo landscape are integral components of the Muskegon watershed. Over time, sediment from the surrounding watershed washes into lakes. Many lakes will eventually fill with sediment, becoming wetlands and in time dry land. This natural aging process is called *eutrophication*, and can take hundreds to thousands of years to occur. Depending on where a lake is in its aging process it is classified as *oligotrophic*, *mesotrophic*, or *eutrophic*.

Eutrophic lakes are farther along in the aging process. They have higher levels of nutrients like phosphorus and nitrates, and are able to support greater amounts of aquatic plant

growth. Clarity can be lower due to algae cells in the water. Eutrophic lakes are generally shallow with mucky bottoms. They support warm water fish like bass and bluegill. Hess and Brooks Lakes are examples of eutrophic lakes. Unfortunately, many human activities can speed up the eutrophication process and lead to unnatural conditions. Fertilizers, septic systems, road runoff, animal wastes, and contaminated stormwater runoff all lead to increased eutrophication.

We, as Hess Lake residents, can do several things to help slow down the eutrophication process. Please use a fertilizer that does <u>not</u> contain phosphorous and has slow release nitrogen. Your grass doesn't need phosphorous, but algae thrives on it. One pound of phosphorous may produce over 10,000 pound of weeds and algae! When you mow, do not dump grass clippings into the lake. In the fall, when you rake leaves, do not dispose of your leaves in the lake. Grass and leaves will decompose in the lake and create food for weeds and algae. Remove fallen leaves, branches and other debris that wash up along the shore to prevent them from decaying in the lake.



UPDATE FROM THE HESS LAKE BOARD

Since last spring, the Hess Lake Board (HLB) met on July 13 and September 14.

During the July 13 meeting, the HLB reviewed progress to date in planning for the new Voluntary Shoreline Restoration Program (details below). We discussed a future Hess Lake Guidebook (coffee table quality). We agreed to wait and see if other lakes might get involved, thus providing a cost savings if produced simultaneously.

The County Drain Commissioner's office reported that the Wheeler Drain sediment basin (above the 2nd check dam) and the channel downstream from the bridge check dam have been cleaned out and the shore areas were seeded and mulched. A heavy February rain event caused the problem. Thanks go to Drain Commissioner Pat Baker for her quick intervention in February and for the dredging solution to the sedimentation problem in the lower channel this spring. HLB members will attend 2 seminars this fall geared toward addressing inland lake issues. The Newaygo County Board of Commissioners passed a resolution on July 22 to support continuing education on not using phosphorus lawn fertilizers. Lawn fertilizers containing phosphorus are detrimental to lake water quality because the phosphorus migrates to the lake triggering algae blooms and excessive weed growth. Please spread the word NOT to use phosphorus lawn fertilizers. Township ordinance prohibits any fertilizing within 25 feet of the lake.

During the September 14 meeting, the HLB reviewed, discussed and approved a \$43,032 special assessment for 2010 weed control and other lake quality efforts. HLB is preparing to use spot treatment or a whole lake treatment for Eurasian Water Milfoil and curly leaf pondweed as counseled by our professional applicator (Weed Control of Indiana). All applications for weed control are safe, permitted and approved by the EPA and Michigan DEQ. The 2010 special assessment gives us the flexibility to be prepared for the more expensive whole lake treatment, if needed. If a whole lake-wide treatment is not needed, future assessments will be lower, as we have done in the past. Your 2010 winter tax bill will reflect the special assessment as follows: \$93.08 (lakefront), \$46.56 (back lot), \$23.28 (3rd tier), and \$187.04 (commercial).

At the request of the HLIA, the HLB also agreed to support HLIA and neighborhood efforts to enforce compliance by a lake resident who has failed to comply with a County Health Department order to replace a failing septic system.

The HLB and Brooks Lake Board (BLB) held a joint meeting on September 14. We jointly reviewed draft findings from a Brooks Lake Water Quality/Feasibility Study conducted by Spicer Engineering this summer. Five Hess Lake inlets were sampled as part of the Brooks Lake study. All 5 inlets to Hess Lake exhibited elevated phosphorus levels. Sampling was done in May. Those tests verified independent tests done by HLIA over the last 10 years. The elevated phosphorus levels come from many sources. Not using lawn fertilizers containing phosphorus and making sure your septic system is pumped regularly (at least every 3 years) or replaced if failing are essential steps you can take to reduce phosphorus loading to our lake. The HLB and BLB agreed to hold another joint meeting in January to continue exploring ways we can work together.

Voluntary Shoreline Restoration Program

Participating in this new program for Brooks and Hess Lakes residents is another way to help reduce phosphorus loading in our lakes. On July 25, 55 folks from both lakes attended an education/ instruction meeting at the Newaygo Middle School to learn how converting traditional turf grass lawns to native vegetation helps absorb nutrients from the soil and runoff before they enter the lake. Participants turned in their restoration area designs, picked the types of <u>free</u> native plants they want to install and chose either a fall 2009 or spring 2010 planting period. The 30 property owners who chose the fall 2009 planting period picked up their free plants on August 29. Another 20 property owners selected the spring 2010 planting period and plans are underway to order plants and arrange for a May 29 plant pick up. This was done under the direction of the HLB, BLB, Muskegon River Watershed Assembly (MRWA) and Muskegon Conservation District funded by MRWA discretionary monies from the Fremont Area Community Foundation and Wege Foundation. We are looking into continuing this program for a 2nd year, depending on available grant funds. Stay tuned for further information. This program is a great way for lakefront owners to become better stewards of their lake by helping to improve water quality and fostering a more natural shore-line landscape.
