

# **HESS LAKE BOARD NEWS**

### 2022 - 2023 Lake Board Update

This is the third year of a five-year lake management program for Hess Lake being coordinated under the direction of the Hess Lake Improvement Board. Key elements of the program include aquatic plant control, watershed management, and carp removal.

In recent years, rooted aquatic plant growth in Hess Lake has been minimal and treatments have been limited. In 2022, no chemical treatments were conducted. Biologists from Progressive AE will be conducting multiple surveys of the lake again this year to gage the amount of rooted plant growth and to determine if any treatments are warranted.

While rooted plant growth has been minimal, the same cannot be said for algae growth in Hess Lake. This imbalance is related in part to the abundant carp population in the lake. An assessment conducted in 2022 found that the carp population in Hess Lake is well above a level that causes adverse water quality impacts. A small test trapping project was conducted last year and while about 400 carp were removed from the lake, thousands more would need to be removed to improve conditions in the lake. This year the lake board is planning an assessment to see what can be done to limit carp spawning and reduce carp numbers over the long term.

In addition to in-lake work, an assessment was completed last year to evaluate the causes of erosion that have long been an issue on Wheeler Drain. Measures to control and stabilize severely eroded streambanks are now being considered for two road crossings. This work would be coordinated by the Muskegon River Watershed Assembly. The lake board continues to remain in contact with the United States Geological Survey, the Michigan Department of Natural Resources, and the Michigan Department of the Environment, Great Lakes, and Energy regarding ongoing management activities on Hess Lake.

What is the Hess Lake Board?

The Hess Lake Board - HLB consists of five people. These five people have legal authority to make decisions on behalf of lake residents, including taxing authority for any lake project they deem necessary. The three lake representatives are appointed positions, with the other two elected.
