IMPORTANT INFORMATION

Hess Lake currently has an overpopulation of catfish, which means there are too many catfish living in the lake. This can lead to an imbalance in the lake's ecosystem, affecting the health and well-being of other aquatic species and their habitats. It's essential to address this issue to ensure that our lake remains a thriving environment for all fish and wildlife.



The HLIA recommends that fishermen catching catfish consider keeping their catch rather than releasing them back into Hess Lake. This suggestion is in line with guidance from the Michigan Department of Natural Resources (MDNR) Fisheries Division, aimed at managing the lake's catfish population effectively.

News from the Hess Lake Board – HLB 2025

Watershed Management: In 2024, several lake board members accompanied county drain commissioner Dale Twing on a tour of the Wheeler Drain. Although there is some farming activity near the drain, much of the land along the drain is wooded or fallow and not being actively farmed. While erosion is occurring in the lower stretches on the drain near the lake, the drain office is conducting periodic clean-outs of the large sediment basin at the mouth of the drain to prevent sediment wash into Hess Lake. Overall, the drain does not currently appear to be having a major adverse impact on lake water quality.

Fisheries Management: We are planning to stock bluegills to improve fishing and to help reduce the carp population (bluegill eat carp eggs).

Aquatic Plants: Rooted plants are important in that they help sustain a healthy fishery and stabilize bottom sediments. To evaluate plant growth in Hess Lake, biologists from Progressive Companies will be conducting plant surveys in May, June, July, and August.

Water Quality Monitoring: Samples will be collected this year over the deep basin in the lake and compared with historical sampling results. Phosphorus and chlorophyll levels (an indirect measure of algal abundance) will be tested.
